They shall be on probation for a period of 2 (two) years from the date of joining and they shall, during the period of probation, appear and pass Departmental Examinations as may be conducted by the MPSC.

They should join duty within 45 days of the date of issue of the order of appointment, failing which and unless the Governor is otherwise pleased to extend the period, the appointment shall be cancelled. They should report themselves to their respective place of postings and to undergo Compulsory Foundation training at ATI, Aizawl for a period of 3(three) months, the actual date and time for which shall be intimated in due course.
