  - vi) A certificate of age or any authenticated document of proof of age.
  - vii) Police verification report on character and antecedent.
  - viii) Degree's Certificate from a recognized University if not already submitted. The Oath /Affirmation should be taken/made before the authority as may be specified by Hon'ble Chief Justice.
2. The person recruited to the service who accepts the appointment on the terms and conditions as stipulated above is required to submit his/her joining report within 10 days from the date of issue of this appointment alongwith documents as 1(i) to (viii) to the Registrar General Gauhati High Court through the Secretary, Law and Judicial Department.
3. The appointee shall be on probation for a period of two years and the period of probation may, for good and sufficient reasons to be recorded in writing, be extended by the Governor in each individual case.
4. A person on probation shall be liable to be discharged from the service at any time without assigning any reason thereof during the period of probation.
5. Every officer appointed in the Entry Grade of Mizoram Judicial Service shall undergo a training course as the High Court may deem fit and proper as per schedule - D of the Mizoram Judicial Service Rules, 2006.
